

# Journey of A Kamasan Artisan

Kamasan is a name of village in the kingdom of Klungkung, East Bali. Kamasan is the centre for traditional Balinese painting. Originally the Kamasan painters/artists served the Kings of Gelgel from the 16<sup>th</sup> century. Kamasan is only two miles from Gelgel, where the court reigned during Bali's golden age.
